# **Anti-Saloon League Records (Collection 208)**

## **History and Scope**

From the name of the organization it is quite evident what its purpose was—opposition to the drinking of alcohol, particularly in public saloons or taverns, what we would call bars.

These Anti-Saloon League Records contain largely the correspondence of James L. Ewin and publications from his collection. Included are letters and publications from many temperance and anti-alcohol organizations between the years 1893 to 1912. One of the values of the collection is to set the tone for the political and social scene during the early years of the foundation of the Seventh-day Adventist Church, as well as to provide primary material for temperance research.

## **Arrangement**

The material is kept in chronological and topical sequence, in much the same order as received. Publications are chronological by title.
