Scope and Content

Daniel Liechty studied at the University of Budapest and completed the theological doctorate at the University of Vienna under the supervision of Professor Alfred Raddatz.

This collection consists of photocopies of books and articles on Sabbatarian Anabaptists and their leader, Andreas Fischer, in 16th and 17th century Europe. This was one wing of the Radical Reformation. There is one folder on Bibliography of Pseudo-Dionysius (Bx 1 Fld 5), as well.
