Raoul Dederen Papers (Collection 410)

Biography

Raoul Dederen (1925–2016), was a Seventh-day Adventist pastor, educator, and administrator. He earned his Master of Arts and Doctor ès Sciences Morales degrees from the University of Geneva, Switzerland. He married Louise Fyon in 1947 and began working as a pastor in Belgium the same year. After serving as a pastor for seven years, he joined the theological faculty of Seminaire Adventiste du Saleve in France (1954), where he taught for the next ten years. In 1964, a guest teaching invitation at the Seventh-day Adventist Theological Seminary in Berrien Springs led to an invitation to join the faculty there. He became a professor of systematic and historical theology and later served as dean of the seminary from 1989 until his retirement in 1991, when he became an active emeritus professor, still teaching and advising doctoral students until 2001.

Scope

The Raoul Dederen Papers include some material from Dederen's early pastoral ministry (largely material issued by various church entities) and some documents relating to his teaching career (largely academic committee activity), but is mostly comprised of documents from the many theological committees he served on.

Arrangement

The overall collection is largely chronologically arranged—beginning with Dederen's pastoral work in Europe, followed by his academic work. His time at Andrews University, in particular, overlapped with much of his service for BRI and its various committees and subcommittees, but the theological committee documents are listed after the documents relating to Andrews, for organizational purposes.

In the "Theological Study Committees" section, papers that were written for presentation to the various committees are generally listed in the order they were presented, according to the agenda or meeting minutes. If both the agenda and minutes were preserved, the papers follow the order listed in the minutes. In cases where neither the agenda nor minutes were preserved, the papers are listed alphabetically by author (or title, if author was not listed). In some cases, the papers listed in the agenda/minutes went through a title change between when they were listed in the agenda/minutes and when they were written/presented. In these instances, the original agenda/minutes title is listed first, followed by the symbol "→" and the paper's new title.

The **Defense Literature Committee** was established in 1943. This was followed by the establishment of the **Committee on Biblical Study and Research** in 1952. These two committees were merged in 1969 and collectively serve as the precursors to the **Biblical Research Institute** (BRI), which was established in 1975. The BRI eventually established several committees and subcommittees to address various theological questions. Many of the committees listed under "Seventh-day Adventist Church Theological Committees" were subcommittees formed by the BRI. The documents in this subsection relate to the main sessions of the BRICOM and its precursors. The sessions are organized chronologically. Righteousness by Faith (RBF)

The Righteousness by Faith Committee was established by the General Conference on May 30, 1973 and was then known as the “**Wieland and Short Manuscript Review Committee.**” It was later renamed the “**Righteousness by Faith Committee**” (RBF) on August 29, 1974. Three study (sub)committees were appointed to serve in a resource and research capacity on behalf of the full committee. These were:

- **Post-1888 History Subcommittee**
- **Righteousness by Faith as a Doctrine and as an Experience Subcommittee**
- **Study, Analysis, and Evaluation of the Messages of Jones and Waggoner Committee**

True Medical Missionary Association (TMMA)
(Formerly known as "Medical Missionary Committee)

The TMMA was made up of "SDA physicians, doctors, nurses, technicians, and laymen" who felt that medical missionary work had been (intentionally) neglected by the church/church administration since Ellen White's time. One of their goals was therefore to have at least 24% of medical missionary workers make up the General Conference Executive Committee. They also wanted to abolish the office of the GC President, establishing a "Chairman" instead (since GC presidents executive committee members had inappropriately exercised "kingly power" in the past. It was also a requirement of membership in the TMMA to be "ardent supporters of Brother Brinsmead and the message he brings." However, the TMMA did eventually withdraw

support of Brinsmead in January 1964.
