James G. Hardie Papers (Collection 042)

Biography

James G. Hardie was a member of the Seventh-day Adventist church in the early 20th century. It appears he was the owner of his own paper-cutting company in New York state. He also wrote extensively on the return of Christ and the missiology of the lost. In summary, he believed in four advents of Christ and a physical kingdom Christ would set up during the millennium for those who never heard the gospel.

He communicated with the General Conference and the *Review and Herald* for 20 years about this topic. Hardie was not a minister but a lay person investigating and proclaiming his beliefs. He sent multiple pamphlets concerning his views on the advents to many conference presidents and church officials. Ellen White received a letter from him, but Uriah Smith responded. Additionally, leaders in the church, A.T. Jones and A.G. Daniells, interacted with Mr. Hardie about his views.

Scope

The collection encompasses his letters with church officials from the beginning of the year 1901 through the year 1928. Within this collection, is a good representation of his beliefs about Revelation, missiology, the advent, and the lost.

Arrangement

The order of the collection is chronological. The letters are all in order and his large volume is ordered consecutively, but it is not fully complete. There are missing chapters; this is how they arrived at the Center for Adventist Research. He was known for sharing his material, especially Volume I, chapters 1 and 2. The writings of his are labeled chapter by chapter.
