# **North American Division Board of Higher Education (Collection 366)**

## **Scope**

The North American Division of Seventh-day Adventists Board of Higher Education serves a coordinating for church-sponsored colleges and universities in the United States and Canada. They also set and uphold criteria and standards the schools need to follow. There are periodic site visits to evaluate how well the school adheres to the standards and criteria. There are also meetings of the Board several times each year and the collection and publication of statistics designed to help the schools adjust and improve relative to their peers.

The user of this collection should note that while portions refer to all of the North American Division schools, other parts of the collection refer to Atlantic Union College, the source for the collection.

This collection is divided into two sections. The first section is an incomplete file of the minutes of the Board of Higher Education from 1972-1988. Also in this file are memorandums from the North American Division Office of Education, and reports and handouts for the board minutes.

The second, and larger, section of the collection is the data produced by the Board of Higher Education. Each year, the BHE Director for Institutional Research sent out a collection of detailed data to each institution including data regarding faculty and student demographics and costs per discipline at their institution, as well as data comparing their statistics with those of the other Seventh-day Adventist institutions in the NAD. The files in this collection are the data sent to Atlantic Union College. Since the longer report was that of institutional discipline costs, the majority of the data will be about AUC. This gives an idea of the type of statistical data available to colleges and the work of the Board of Higher Education and the Office of Institutional Research during this time.

## **Arrangement**

The material was originally kept in three-ring binders. The collection is arranged topically and chronologically, but the binders do overlap each other in years.
