Scope and Content

Biographical

Edward Alexander Sutherland (1865-1955) was one of the most notable and successful educational reformers of the Seventh-day Adventist Church. He served the church for sixty years, fifty-three of them as president of four Adventist colleges, and forty-one of those years as president of Madison College--a self-supporting Adventist institution near Nashville, Tennessee, that received no direct financial assistance from the denomination. After leaving Emmanuel Missionary College in Berrien Springs, Michigan,

Sutherland, along with Percy T. Magan, and a few others founded and led Madison College. He worked closely with Ellen White to model Madison along the educational philosophy in her writings. Sutherland was president of Madison at his death in 1955.

Sutherland led in the campaign to eradicate the classics from Seventh-day Adventist colleges and to place the Bible at the center of the curriculum. His philosophy of holistic education permanently altered the thrust of Adventist education from the elementary through the college levels. He was instrumental in the creation of the Adventist elementary and secondary-school system and a distinctive teacher-training program. Placing major emphasis on manual labor, Sutherland developed a viable work-study curriculum and sought to instill in Adventist youth a deep commitment to being missionaries regardless of their chosen career.

Attuned to the reforms of his era, Sutherland's work was reflective of the educational innovations attempted both in the Adventist church and in society at large around the turn of the century. His aggressive actions brought to fruition many of the reforms that his Adventist predecessors in the United States had not been able to consummate, as well as reforms not previously attempted by them. Sutherland's efforts to integrate faith and learning illuminate the most significant reform period in the early years of Adventist education.

<u>Scope</u>

It is important to understand that the Center for Adventist Research, for many years, held two large Madison-related collections received at different times from different sources but with extensive overlap. These collections remained unprocessed. Additionally, the Center held a small Sutherland collection received from yet another source, plus collections from Warren Ashworth and a White/Sutherland correspondence-focused collection. When the Center received a third large Madison-related collection in 2013, with still more considerable overlap with the existing two collections, we embarked on a multi-year task of merging the different but overlapping collections into one large, comprehensive whole. Through this work, we "spun out"

more Sutherland personal material from the institutional collections which were combined to augment the Sutherland Collection here described. Several other personal collections spun out as well. These are the DeGraw, Ard, and Scott collections.

This collection, while drawing from a very large institutional collection, is not comprehensive in its coverage of Sutherland's life and career. However, the Andrews University Center for Adventist Research holds several other manuscript collections. that, when taken together with this one, will provide a full coverage of Sutherland's remarkable and prolific life. One collection is the collected primary sources from the work of Warren Ashworth who prepared a dissertation on Sutherland entitled. Edward Alexander Sutherland and the Seventh-day Adventist Educational Reform: the Denominational Years, in 1986. [See G.S Diss. A831.] At this point, April 2017, the Ashworth source material collection is not ready for research use. There is a large Madison Institutions manuscript collection [see Collection 167] which has a wide variety of resources related to Sutherland. As the founder and leader of Madison for so many years, Madison's history is closely intertwined with Sutherland. There is yet another collection with a focus on correspondence between Sutherland, Ellen White and W. C. White. [See Collection 231.] Lastly, there are several related collections of people who were associated with Sutherland during his Madison years. These include Bessie DeGraw [Collection 339], the Ard Family, and Mary Kate Gafford.

Content

This personal collection contains some Sutherland family materials and letters as well as a portion of his prolific writing and presentation output. Sutherland was a trustee of two estates, papers of which are included here. The estates are those of John S. Cominns and Mary and Ellen Woodworth. Also included are some clippings and a few personal artifacts.

Provenance

The source of the bulk of this collection is not known. Additional materials came into it from the several Madison-related collections held by the Center. The original materials likely came in the 1980s while the newest additions came in 2013 from the Madison College Alumni Association.

Use

All users of this collection are required to completer the "Application to Use Unpublished Records," and to observe the regulations specified in the "Patron Agreement" and "Researcher's Code of Conduct."
