Ellen G. White Compilation Collection (Collection 140)

Scope and Content

This collection displays at least two different functions regarding the letters and manuscripts of Ellen G. White during her lifetime and afterward:

1. How Ellen White's office functioned in the 1890s, 1900s, and perhaps even later regarding the production of duplicate copies of her letters and manuscripts for distribution purposes. This collection shows the production of multiple copies of individual letters and manuscripts dating over twenty plus years.
2. How individuals, in the days before the widespread availability of published letters and manuscripts, would collect White's writings for whatever purpose they needed. These were arranged chronologically, by subject, or by no apparent order.

This collection appears to be a merger of several collections or groups compiled by different people or groups and, at some later point, merged together into what we have today. The origins of this merged collection are not known. What is now the first and second series (I Letters and II Manuscripts) in this collection came from Ellen White's office. There are letters and manuscripts copied from the office file copy. There are also numerous occasions where the copy in this collection has verbiage not included in the official file copy today.

The third series of this collection contains compilations credited to the following individuals and group:

- Jethro Kloss
- Daniel Kress
- W. A. Colcord
- Emmanuel Missionary College

The ones who compiled these sets likely had access to the White Estate office files or some other way to access a wide variety of subjects and date ranges that were likely only available at the White Estate office. These were likely to have been compiled following Mrs. White's death in 1915.

The fourth series are galley proofs and several small publications with pages containing the original text used in the compiled publication represented by the galley proofs. In other words, the galley proofs, a pre-printing step for a new publication, are for a publication not previously available, and this new publication is a compilation from multiple existing printed sources. The White Estate office selected portions from existing Ellen White writings, re-typed and edited—not changing the text except to fit the subject and space needs of the new publication. This re-typed manuscript would go to the printer who set the type for the new publication. They would print a galley proof

and return that to the White Estate office for review. The office may correct or add content to fit the current need. Once the office was satisfied with the text on the first or subsequent galley proofs, the printer would take the now corrected/updated galley to the printing press and print the book or publication for sale and distribution to the public.

Several additional interesting pieces of information come from this collection. This is not meant to be a complete list as further research will undoubtedly reveal more.

- Some galley proofs show how many copies of the publication were published. This information is not generally known.
- The White Estate office prepared multiple copies of letters and manuscripts for distribution in some form. This was in the days before photocopy machines and computer printers. A typist needed to type multiple copies at one time using multiple layers of carbon paper on what we call "onionskin" paper. This very thin paper allows multiple pages to be produced with each typing. These "onionskin" copies are what we find in this collection.
- Re-typing of letters and manuscripts in this manner has the potential to introduce some minor errors into the text of the copies. The copies were likely very carefully reviewed for mistakes, but humans being humans, there is the potential for some mistyping.
- People went to great lengths to have a file of unpublished material from Ellen White's writings. Since the non-book portion of Ellen White's writings were not readily available—largely unpublished—this material would be new and fresh when they used it in their own compilations and study. In those days, compilations produced by anyone other than the White Estate office, would doubtless pass through that office for review and revision before going into print.

People involved in creating the documents in this collection:

Minnie Violet Hawkins (1874-1963) (M.V.H., later M.V.C.). Her initials are found throughout much of this collection. The first time Ellen White hired Minnie was in 1896 to 1900 when she was in Australia. Minnie became a very close personal friend to Mrs. White in addition to being her literary assistant. Most of the material in this collection came from this period of time. Back in California at Elmshaven, in 1905, Mrs. White asked Minnie to help her again with preparing her writings for publication. This relationship extended to Mrs. White's death in 1915. Minnie stayed at the office perhaps as late as 1917. During this time, Minnie met Clarence C. Crisler (1877-1936), one of Ellen White's secretaries. Minnie and Clarence married and served at the White Estate office and in China.

- The relationship between Minnie and Clarence and the times they served in Ellen White's office may explain why most of the letters and manuscripts in this collection have one or both of their initials beneath Ellen White's signature. This shows Minnie and Clarence produced copies of the letters and manuscripts found here.
- Many of the Ellen White writings in this collection are very close to the original version of the letter. Sometimes, they may have notations and changes that did not make it into the official copy.

For example, several letters contain words, phrases, or even sentences that do not appear on the White Estate website (<https://egwwritings.org/>). Additionally, in many of these documents, various corrections of words and small phrases appear that were included in the final official version of these letters and manuscripts. Notations appear in the following register when the processors became aware of variations.

- Another interesting detail is the number of copies the typists made of these documents, which could range from 2 copies to 50, as is the case with Box 2, Folder 37. These copies were likely made for church leaders at the General Conference and other levels due to their interest in what God said through Mrs. White on topics such as administration, leadership, education, and evangelism.

The compilers

- Jethro Kloss (1863-1946) [Health reformer]
- Daniel Kress (1862-1956) [Physician and health reformer]
- W. A. Colcord (1860-1935) [Minister, administrator, editor, and worked in Ellen White's office for several years]
- Battle Creek College/Emmanuel Missionary College [First Seventh-day Adventist institution of higher education]

These four groups of compilations contain letters and manuscripts by Ellen G. White. They are organized by date [Kloss] or subject [the others], such as health or education. There are also a few other topics, such as counsel to parents and children, communion, and leadership.

These compilations

- Were made after Minnie's work at the White Estate ended—no later than 1917—based on dates from the 1920s on some of the copies.
- Contain some original materials or material closer to the original letter or manuscript. For example, there are two original letters from Willie White (see Box 2, Folder 9 and 10); and two articles from A. T. Jones (see Box 7, Folder 6) with editing corrections showing that they could be the originals.

Arrangement

The Center for Adventist Research organized this collection as it is now. It lacked organization when received. Organization and description was performed in August 2023 by a group of White Estate Research Center Directors in a class at the Andrews University Center for Adventist Research. Cristian Gonzales completed their work in the fall of 2023.

Arrangement is by letters followed by manuscripts. The third part is the four different compilations that are kept, first by the compiler and second in the order left by the compiler, either by date or by subject. Also included are the galley proofs and some other publications that do not necessarily relate to the rest of the collection.

Provenance

The first two parts of the collection may have come from F. C. Gilbert at South Lancaster Academy in Massachusetts. Gilbert's name appears on the cover of Box 7, Folder 4. How the other four compilations came together is not known. It is possible it was all given to the Seventh-day Adventist Theological Seminary, which transferred it to the Adventist Heritage Center in the 1970s—that date is based on the collection number within the Center for Adventist Research collection numbering. There is no donation record.
